



# The State of Retailer-to-Consumer Shipping (2022)














# Nevada – SB 307





### **IDAHO**

"A licensee who holds a license for the retail sale of wine for consumption off the licensed premises may ship not more than two (2) cases of wine, containing not more than nine (9) liters per case, per shipment, for personal use and not for resale, directly to a resident of another state if the state to which the wine is sent allows residents of this state to receive wine sent from that state without payment of additional state tax, fees or charges. The sale shall be considered to have occurred in this state."



# Please Support Free Trade in Wine Shipments For New Yorkers



For years New Yorkers have been banned from receiving wine shipments from out-of-state wine stores, retailers, auction houses and wine-of-the-month clubs. But with the introduction of a retailer wine shipping bill in the NY Assembly and Senate, New Yorkers have a chance to bring free trade and wine freedom to their state.

New York Senator Shelley Mayer and Assemblywoman Amy Paulin have introduced legislation that will end this ban on shipments to New York wine lovers from out-of-state retailers. Assemblywoman Paulin introduced A799 in the Assembly and Senator Mayer intrduced the same bill, S7740 in the NY Senate.
